

## Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **ELIGIBILITY:** The 14 Days of Giveaways Contest (“Sweepstakes”) is sponsored by Arena Operating Company, Ltd. (“Sponsor”). The Sweepstakes is open to all legal residents of Florida over 18 years old (“Eligible Persons”), Employees and officers of Sponsor and Sponsor’s parent companies, subsidiaries, affiliates and related entities, advertising agencies, authorized dealers, promotional suppliers, prize providers (each of the aforementioned entities collectively, with Sponsor, the “Sweepstakes Entities”) and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win. The Sweepstakes shall commence on December 1, 2024, and the deadline for The Panthers Marketing Department to receive all mailed-in and digital entries for the Sweepstakes is December 14, 2024, at 11:59 PM Eastern Standard Time (“Sweepstakes Time Period”). No entries will be accepted after such time.

3. **ODDS OF WINNER SELECTION AND PRIZE:** Following the conclusion of the Sweepstakes Time Period, Sponsor shall select one (1) Eligible Person (“Winner”) from a random drawing of all eligible entries received during each period of the Sweepstakes Period identified below (each a “Prize Period”) to receive two (2) tickets for seats to be determined by Sponsor in its sole discretion to one (1) performance of the applicable Event to take place at the sports and entertainment facility currently known as Amerant Bank Arena on the Event Date identified below (each such pair of tickets is a “Prize”, and all such pairs of tickets, collectively, are the “Prizes”). 4. WINNER NOTIFICATION: Each Winner shall be announced on or around the final day of the applicable Prize Period. Announcement of Winner and instructions for receiving the Prize will be sent to the e-mail address or phone number supplied on entry. Each entrant is responsible for monitoring his/her e-mail account or phone number provided for prize notification and receipt or other communications related to this Sweepstakes. If Winner cannot be reached by the Sponsor within (1) day or if the Prize is returned as undeliverable, Winner shall forfeit the Prize and the Prize will be awarded to an alternate winner. Except as determined by the Sponsor in its sole discretion, no substitution of Prize is offered, no transfer of Prize to a third party is permitted, and Prize may not be redeemed for cash value. Winner will be solely responsible for all applicable federal, state, and local taxes arising in connection with the Prize. All other expenses on the receipt and use of Prize not specifically mentioned herein are solely the responsibility of the Winner. Any portion of Prize not accepted by Winner will be awarded to a substitute winner in accordance with Section 4 above. In no event will Sponsor be liable to award more than the number of prizes stated in these Official Rules.

6. ACCEPTABLE CONDUCT: By entering this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification. Sponsor reserves the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. LIMITATIONS OF LIABILITY: The Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of the Internet, the Application (if applicable), or any combination thereof; or (e) any injury or damage to participant's or to any

other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes. RELEASES: All entrants, as a condition of entry into the Sweepstakes, agree to release the Sweepstakes Entities from and against any and all liability, claims or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with: accessing the internet; submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership or use of the Prize awarded; preparing for, participating in, attending or traveling to and/or from any prize-related activity; or any typographical or other error in these Official Rules or the announcement or offering of any prize. The Sponsor makes no representations or warranties of any kind concerning the appearance, safety or performance of the Prize.

By accepting the Prize, Winner agrees for him or herself and for his or her heirs, executors, and administrators to release, indemnify and hold harmless the Sweepstakes Entities, and each of their respective equity holders, successors, owners, general and limited partners, officers, shareholders, members, directors, employees, agents, and representatives from and against any and all liability for any loss, harm, damages, costs or expenses, including without limitation property damages, personal injury, and/or death, arising out of (i) participating in this Sweepstakes, (ii) the acceptance, possession, use or misuse of the Prize, (iii) preparing for, participating in and/or traveling to or from any Prize-related activity, (iv) claims based on rights of publicity, rights of privacy, or defamation, or (v) Prize delivery.
